The Interagency Agreement is therefore modified as follows:  Under Article VII - <u>Clothing and Equipment</u> , add the following paragraph:  "During FY88, the contractor is authorized to spend up to \$5,000.00 from presently available funds for miscellaneous consumable materials and supplies such as special clothing and accessories. Items procured and funds expended shall be identified in periodic invoices, but accountability for ultimate disposition is not required."  All other terms and conditions, including the monetary value of \$546,755.64 remain the same. Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
