SUMMARY

B. Mallett called to clarify following:

1. Status of license in Naperville, IL. Mara Chermisin stated she is now the contact pt. for the license. They removed all material few years ago. The license was really only for sales reps. in U.S. to receive & redistribute smoke detectors from manufacturers in Canada. B.
