
14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible)

The purpose of this modification is to provide incremental funding in the amount of \$649,000. Subsection B.2, paragraph B. is revised as follows:

The amount presently obligated by the Government with respect to the contract is increased by \$649,000 from \$1,600,000 to \$2,249,000. Estimated reimbursable costs are increased by \$600,926 from \$1,481,481 to \$2,082,407. The available award fee is increased by \$48,074 from \$118,519 to \$166,593. The base fee remains 0.
