Gentlemen:

Please find enclosed an amendment to your NRC Material License.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the Region I Material Licensing Section, (215) 337-5239, so that we can provide appropriate corrections and answers.

Please be advised that you must conduct your program involving licensed radioactive materials in accordance with the conditions of your NRC license, representations made in your license application, and NRC regulations. In particular, please note the items in the enclosed, "Requirements for Materials Licensees."

Radium-226, which is naturally occurring is not byproduct material as defined in Section 30.4(d) of Title 10, Code of Federal Regulations, Part 30 and is not subject to licensing by the NRC. Therefore, you may procure and use it without amendment to your byproduct material license.

You should contact your State regulatory authorities to determine the State licensing or registration requirements for use of this product.

Although an amendment was not required to permit storage of the radium-226 source, an amendment was required to update your authorized users in Condition 11.

Since serious consequences to employees and the public can result from failure to comply with NRC requirements, the NRC expects licensees to pay meticulous attention to detail and to achieve the high standard of compliance which the NRC expects of its licensees.

You will be periodically inspected by NRC. A fee may be charged for inspections in accordance with 10 CFR Part 170. Failure to conduct your program safely and in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in prompt and vigorous enforcement action against you.
