In particular, please note the items in the enclosed, "Requirements for Materials Licensees."

It is our understanding from your letter dated February 9, 1987 that your AECL Teletherapy Unit will soon be removed and your license terminated. We have enclosed NRC Form 314 which you should use when submitting your termination request for this license.

Please note your license has been issued in accordance with 10 CFR 35 (effective April 1, 1987).

Since serious consequences to employees and the public can result from failure to comply with NRC requirements, the NRC expects licensees to pay meticulous attention to detail and to achieve the high standard of compliance which the NRC expects of its licensees.

You will be periodically inspected by NRC. A fee may be charged for inspections in accordance with 10 CFR Part 170. Failure to conduct your program safely and in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in prompt and vigorous enforcement action against you. This could include issuance of a notice of violation, or in case of serious violations, an imposition of a civil penalty or an order suspending, modifying or revoking your license as specified in the General Policy and Procedures for NRC Enforcement Actions, 10 CFR Part 2, Appendix C.


