Gentlemen:

This refers to your Proposed Change No. 130 which you submitted with your letter dated August 11, 1975. In this submittal you proposed to incorporate a new paragraph H "Administrative Controls" in the Technical Specifications, Appendix A to Operating License No. DPR-3 for Yankee Nuclear Power Station (Yankee-Rowe).

We have reviewed your submittal and find that the proposed paragraph H does not fully conform with Section 6 in our Standard Technical Specifications, which we sent you for guidance with our letter of March 26, 1975. The specific areas of difference which have been discussed between our staffs on September 16, 1975, include the following:

1. The needed modification of your proposed Specification 6.5.2.2, involving either identification of position titles or specifying minimum qualifications of the person assigned to the Nuclear Safety Audit and Review Committee;
2. The needed revisions of your proposed Specifications 6.5.2.7, 6.5.2.8 and 6.5.2.10 (Review, Audits and Records, respectively) relating to the activities of the Nuclear Safety Audit and Review Committee to conform with the like numbered requirements in our standard Section 6 Technical Specifications; and c/p

3. The needed documentation, review and approval of temporary changes to procedures within 7 days instead of 30 days as proposed in Specification 6.8.3.C.

We request that you revise your proposed change to incorporate these items or provide substantiating bases for any departures from the staff positions on these items.
