Following the presentation, the NRC will respond to questions specific to the safety performance of the stations and the NRC's role in ensuring safe plant operations.

**CATEGORY:** This is a Category 3 meeting. The webinar will begin with a brief presentation by NRC staff on the NRC's assessment process for performance at reactor sites during 2019. Following the presentation, members of the public will have the opportunity to ask questions specific to safety performance and the NRC's role in ensuring safe plant operations. Those wishing to submit questions can do so in writing or verbally during the webinar. The NRC staff will provide guidance during the webinar on the methods available to ask a question.
