SUBJECT: SUMMARY OF PUBLIC MEETING

On June 3, 2020, at 5:30 p.m., the U.S. Nuclear Regulatory Commission (NRC) held a two-part public webinar to discuss the NRC's assessment of the safety performance at Seabrook Station for 2019. During the first part of the webinar, the NRC staff presented the agency's safety performance assessment at Seabrook for the period of January 1 through December 31, 2019, the NRC's role in ensuring safe plant operations, and the NRC actions in response to the national health emergency. The second part of the webinar provided members of the public with an opportunity to submit questions verbally or in writing on topics discussed during the first part of the webinar. Members of the public, State and local officials, elected officials or their staff, and members of the media participated in the meeting. Enclosure 1 is a list of those who participated in the webinar. The following NRC staff provided presentations during the webinar: Dan Collins (Director, Division of Reactor Projects (DRP)), Brice Bickett (Chief, DRP), Paul Cataldo (Senior Resident Inspector, DRP), Brett Klukan (Regional Counsel), and Justin Poole (Project Manager, Nuclear Reactor Regulation).
