by NRC staff on the agency's assessment of performance for Indian Point during 2019, the review process for the proposed Indian Point Energy Center license transfer from Entergy Nuclear Operations, Inc. to Holtec Decommissioning International, LLC, and the NRC's review of Entergy's safety evaluation and hazard analysis of the AIM pipeline near the Indian Point site. This meeting will also address the commitment to Congresswoman Nita Lowey to hold a public meeting on the Expert Team's findings relating to the AIM gas pipeline, as stated in the April 15, 2020, letter from NRC Chairman Kristine Svnicki (NRC's Agencywide Documents Access and Management System (ADAMS) Accession Number ML20104C075), and the proposed license transfer process of Indian Point to Holtec, as stated in the April 16, 2020, letter from Margaret M. Doane, NRC Executive Director for Operations (ADAMS Accession Number ML20092H996).
