Damaris,

In May 2020, Jim Hutson, a DOE contractor, informed the NRC that DOE (primarily Que Nguyen) had completed reviewing Centrus Energy Corp.'s cyber security plan (SEC-18-0002), which was first submitted as part of Centrus' request dated February 6, 2020 to the NRC for approval of the classified matter security program for the Technology and Manufacturing Center (TMC) in Oak Ridge Tennessee (ML20050F863), and later as part of the request dated March 31, 2020 for approval of the classified matter security program for the American Centrifuge Plant and the Lead Cascade Facility in Piketon Ohio (ML20136A471). According to Jim, DOE had no comments on the cyber security plan submitted on March 31, 2020, but that DOE did have comments for the one submitted on February 6, 2020. On June 11, 2020, Jim Hutson encrypted and e-mailed the final draft of the comments to me and Keith.

On June 23, 2020, NRC and DOE staff held a conference call with Centrus staff to discuss DOE's comments. The participants of the call were as follows:

During the call, Centrus staff informed the NRC and DOE staff that upon its approval, the SEC-18-0002 submitted on March 31, 2020 would supersede the cyber security plan, also identified as SEC-18-0002, submitted on March 31, 2020. After confirming that this was

also documented in Centrus' March 31, 2020 submittal, the NRC and DOE staff agreed that Centrus need not address **several of** the attached comments, since the NRC's schedule for completing its review of the higher priority Piketon classified matter security program by the end of October 2020, is well ahead of the scheduled date of the end of February 2021 for the classified matter security program for the TMC.
