Dear Ma'am/Sir:

The purpose of this correspondence is to inform the Licensing Assistance Team of the status of radioactive materials located at the Milan Army Ammunition Plant, Milan, TN managed by American Ordnance LLC. This letter is to inform you of our plans to request the termination of AO's NRC Materials License SUB-1355. The Army has declared the Milan Army Ammunition Plant (MLAAP) as excess and most of the Department of Defense (DoD) ammunition and explosives have been shipped from MLAAP to other government facilities. This included the Depleted Uranium (DU) munitions which were stored at MLAAP. In previous years, the DU was handled, assembled, and stored the pre-manufactured DU cores which were encased in the 105MM and 120MM tank projectiles, and complete rounds. In recent years, the amount of DU munitions stored on MLAAP has been reduced to a relatively small amount and the last shipment of the DU ammunition was shipped in February 2020.

The NRC License also lists DU metals for X-ray shielding. Due to the shutdown of the X-ray facility in 2012, approximately 18 Kg (40 lbs.) of the DU shielding, in one of the X-ray systems, was shipped in 2018 for proper disposal. There is one X-Ray system remaining on site which has approximately 136 Kg (300 lbs.) of DU shielding. This system is in the process of being excessed and shipped to another location. It is anticipated the aforementioned will be completed by the end of October 2020. Once this has been accomplished all DU materials listed on the NRC Materials License will have been removed from MLAAP. We are in the process of gathering information in order to complete the NRC FORM 314 "Certificate of Disposition of Materials" and for final submission. Please provide any guidance and/or advice on the proper steps and actions required to complete the license termination process.

Thank you for all of the cooperation, support, and assistance provided throughout the year's AO has possessed this license. We trust this letter will provide the proper notice of the intent to terminate NRC License SUB-1355. Again, please let my Safety Manager or I know of any additional actions needed to assist AO in expediting the license termination process. It is our intent to complete this process as soon as possible to avoid additional license fees for 2021.
