Category: This is a Category 3 meeting. Public participation is actively sought for this meeting to fully engage the public in a discussion of regulatory issues.

Purpose: The Nuclear Regulatory Commission (NRC) staff is hosting another webinar to provide an opportunity for external stakeholders and the NRC staff to exchange information on the NRC's development of Part 53 preliminary proposed rule language for advanced nuclear reactors. The Part 53 preliminary proposed rule language for Subpart C, "Requirements for Design and Analysis," and the Facility Safety Program section of Subpart F, "Requirements for Operation," are available in the NRC Agencywide Documents Access and Management System (ADAMS) under accession number ML20337A432.
