Subject: Request for Additional Information and Termination Letter for Connecticut Heart Group

Discussion: Hartford HealthCare Medical Group (HHMG) had submitted an amendment request to add the Connecticut Heart Group (CHG) facility (under NRC License No. 06-30080-01) to its license and stated that the CHG license would no longer be needed. The letter appeared to be signed by only HHMG management. I spoke with Hartford's Corporate RSO to request that CHG submit a formal termination request and have CHG management concur on HHMG's amendment request letter dated 12/3/2020. Ms. Blankenship confirmed that Dr. Corning and Dr. Kapoor (two of the three parties who signed the HHMG letter) are both senior management for CHG, but had used their new HHMG titles in the letter. She said that she would have them submit a formal termination request for CHG and indicate their CHG titles in the letter. Once we receive the termination request, we can open a licensing package, and issue the actions concurrently.

Action Required: Wait for additional information, and then issue amendment/termination.
