COMMENT PERIOD RELATED TO THE POST-SHUTDOWN
DECOMMISSIONING ACTIVITIES REPORT AND SITE-SPECIFIC
DECOMMISSIONING COST ESTIMATE (EPID L-2020-LLL-0005)

Dear Mr. Moul:

Enclosed is a copy of a second *Federal Register* notice extending the comment period for the post-shutdown decommissioning activities report (PSDAR), including the site-specific decommissioning cost estimate (DCE), for the Duane Arnold Energy Center (DAEC).

On April 2, 2020, NextEra Energy Duane Arnold, LLC (the licensee), submitted a letter containing the DAEC PSDAR, which included the DCE (Agencywide Documents Access and Management System (ADAMS) Accession No. ML20094F603). In a *Federal Register* notice dated June 19, 2020 (85 FR 37116), the U.S. Nuclear Regulatory Commission (NRC) informed the public of a meeting to be held on July 28, 2020, to discuss and accept comments on the DAEC PSDAR and DCE. Due to travel restrictions associated with the Coronavirus Disease 2019 (COVID-19) public health emergency (PHE), this meeting was postponed.

The current public comment period closed on October 19, 2020, was reopened on October 26, 2020, and closed again on February 19, 2021. Section 50.82(a)(4)(ii) of Title 10 of the *Code of Federal Regulations* (10 CFR) requires that the NRC conduct a PSDAR public meeting in the vicinity of a decommissioning licensee's facility. The NRC will hold a public meeting to discuss the DAEC PSDAR's content and receive comments once conditions associated with the COVID-19 PHE support in-person meetings. As such, the NRC has decided to extend the DAEC PSDAR and DCE public comment period for a second time until August 19, 2021, and will consider further extensions as the COVID-19 PHE conditions warrant. This will also allow more time for members of the public to develop and submit comments.

In accordance with 10 CFR 2.390 of the NRC's "Agency Rules of Practice and Procedure," a copy of this letter will be available electronically for public inspection in the NRC Public Document Room or from the Publicly Available Records component of NRC's Agencywide Documents Access and Management System (ADAMS). ADAMS is accessible from the NRC Web site at <http://www.nrc.gov/reading-rm/adams.html>.
