General Comment

I object to the transfer of licenses and ownership, from current owner Entergy Nuclear to proposed new owner Holtec International, for the Palisades and Big Rock Point nuclear power plant sites.

First and foremost, I object to the extremely short timeline of 30 to comment on this complicated issue, of interest to residents of the states where the plants are located, the states that the radioactive waste will be transported through to be dumped in Texas and New Mexico and residents of Texas and New Mexico where these temporary storage sites are being set up out in the desert where there are no contingency plans to deal with leakages, accidents and potential incidents including terrorist attacks.

A much longer comment period (at least 90 days) would be appropriate to allow all affected parties to effectively weigh in.

Additionally, Holtec is invested in profit, not safety. Holtec is applying to store high level nuclear waste temporarily in the desert of New Mexico. Holtec wants to drag this waste across the country in flimsy transportation containers and partially bury it in New Mexico. These containers are not made to last more than 40 years and there is no permanent location to relocate these deteriorating vessels to. There is no plan to repackage this high level nuclear waste in case it leaks in New Mexico or before it is moved to some yet to be determined and likely never to be determined fantasy site. Instead, the waste will sit in the New Mexican Desert where it will leak and irradiate the area.

Holtec has not appropriately planned for safe transportation of high level waste via rail. The rail system cannot support the weight of the transport cars which will deform the rails and will be unsteady and unwieldy. It seems Holtec is more interested in profits than safety. So this would generalize to the

management of any nuclear power plants it has a license to operate.

Texas has recently gotten a taste of what happens when profits over safety hold sway. Texas turned most of its electric grid over to companies that wanted to run it for profit and safety went out the window. The Texas electric grid did not function adequately during a winter storm (a predicted winter storm) and lives were lost along with billions of dollars it will cost Texas consumers, taxpayers, and rate payers. Lots of promises were made by these private companies about safety and reliability when Texas gave these companies control of their electric grid, but when push came to shove, costs were cut and safety was the last consideration behind profit. Promises are cheap and Holtec makes many promises but does not want to pony up to cover real risks that it will expose the public to as it tries to wring every penny out of these plants and their decommissioning. Holtec has recommended very little security at their waste site in New Mexico in a time of
