Dear Mr. Staskiewicz:

I would like to nominate Mr. Gurcharan S. Matharu and Mr. Kenneth A. Miller as the authorized Nuclear Regulatory Commission (NRC) representatives and Ms. Sheila Ray as the alternate representative on the Institute of Electrical and Electronics Engineers (IEEE) Nuclear Power Engineering Committee (NPEC), Subcommittee 4 on Auxiliary Power. Mr. Matharu, Senior Electrical Engineer, Mr. Miller, Senior Electrical Engineer, and Ms. Ray, Senior Electrical Engineer, are responsible for activities related to auxiliary power and bring necessary experience and education to support the development and maintenance of standards in Subcommittee 4.

In accordance with the Office of Management and Budget Circular No. A-119, "Federal Participation in the Development and Use of Voluntary Consensus Standards and in Conformity Assessment Activities," January 27, 2016, the participation on a committee of an NRC-authorized representative does not connote agency agreement with, or endorsement of, decisions reached by the committee, or of standards approved and published as a result of the committee's efforts. Agency representatives participating on consensus standards developing groups will, to the extent possible, ascertain the views of the agency on matters of interest and will express views that are consistent with established agency views.

However, the NRC's endorsement of these standards, if desired by the NRC, would be part of a separate activity, such as incorporation by reference into rulemaking or endorsement in an NRC regulatory guide.


