Enclosed is Amendment No. 88 to your U.S. Nuclear Regulatory Commission (NRC) Material License No. 13-03284-02 for Reid Hospital and Health Care Services in accordance with licensee's requests dated November 20, 2020, and December 29, 2020. Please note that the license has been renewed for 15 years.

You will be periodically inspected by NRC. The NRC may issue a notice of violation, imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

The NRC's Safety Culture Policy Statement became effective in June 2011. While a policy statement and not a regulation, it sets forth the agency's *expectations* for individuals and organizations to establish and maintain a positive safety culture.
