This proceeding involves an application seeking a twenty-year subsequent license renewal of Renewed Facility Operating License Nos. DPR-24 and DPR-27, which authorize NextEra Energy Point Beach, LLC to operate the Point Beach Nuclear Plant, Units 1 and 2, located near Manitowoc, Wisconsin, until, respectively, October 5, 2030 and March 8, 2033. In response to a notice published in the Federal Register announcing the opportunity to request a hearing, see 86 Fed. Reg. 6684 (Jan. 22, 2021), a hearing request was filed on March 23, 2021, on behalf of Physicians for Social Responsibility Wisconsin.
