Transmittal of PWROG Presentation Materials to Support the Closed Meeting between the NRC and the Pressurized Water Owners Group (PWROG) to discuss Generation III SHIELD Testing Related to PWROG-14001-P-A Revision 1

The PWR Owners Group is working with the NRC staff to reconsider the Generation III SHIELD SDS Testing that is currently a limitation set forth in PWROG-14001-P-A Revision 1. The PWROG plans to provide additional information to the NRC staff in the coming months that supports reconsideration and this transmittal contains the presentation that covers the approach the PWROG would like to take.


