Category: This is a Comment-Gathering Meeting. The purpose of this meeting is for NRC staff to meet directly with individuals to receive comments from participants on specific NRC decisions and actions to ensure that NRC staff understands their views and concerns.

Purpose: The purpose of this meeting is to provide information about the proposed rule to incorporate by reference American Society of Mechanical Engineers (ASME) codes into the U.S. Nuclear Regulatory Commission (NRC) regulations. Specifically, the NRC intends to incorporate by reference the 2019 Edition of the ASME Boiler and Pressure Vessel (BPV) Code and the 2020 Edition of Operation and Maintenance of Nuclear Power Plants, Division 1, OM Code: Section IST. The NRC is also intends to incorporate by reference the 2011 Addenda to ASME NQA-1-2008, "Quality Assurance Requirements for Nuclear Facility Applications," (ASME NQA-1b-2011), and the 2012 and 2015 Editions of ASME NQA-1. The proposed rule was published in the Federal Register on March 26, 2021 (86 FR 16087). The public comment period is open through May 26, 2021.
