Dear Mr. Frye:

Enclosed is Amendment No. 04 to your U.S. Nuclear Regulatory Commission (NRC) Materials License No. 24-32751-01 in accordance with your January 15, 2021 and March 26, 2021 requests.

In accordance with your requests, this amendment includes the following changes to your license:

- Adds authorization for the Troxler Electronic Laboratories, Inc., Model 4640, 4640B and 3241-C portable gauging devices;
- Increase the license authorization for the Troxler Electronic Laboratories, Inc., Model 3400 Series and 3241-D portable gauging devices;
- Addition of your new location in Palmyra, Missouri, for use as a permanent storage site; and
- Removal of the permanent storage site in Neosho, Missouri.

Your request identified that no licensed radioactive materials were previously stored at your permanent storage site in Neosho, Missouri. Based on this information, your facility is suitable for release to unrestricted use.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. NRC Region III office at (630) 829-9887 so that we may provide appropriate corrections and answers.

An environmental assessment for this action is not required because this action is categorically excluded under Title 10 of the *Code of Federal Regulations* (CFR) Section 51.22(c).

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation; or imposition of a civil penalty; or an Order

suspending, modifying, or revoking your license as specified in the NRC Enforcement Policy. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance that NRC expects of its licensees.
