safety performance at the Region IV plants that were in the Licensee Response Column (Column 1) of the Reactor Oversight Process Action Matrix in 2020. Following the presentation, the NRC will respond to questions specific to the safety performance of the stations and the

NRC's role in ensuring safe plant operations.
