Category: This is an Information Meeting with a Question and Answer Session. The purpose of this meeting is for the NRC staff to meet directly with individuals to discuss regulatory and technical issues. Attendees will have an opportunity to ask questions of the NRC staff or make comments about the issues discussed throughout the meeting; however, the NRC is not actively soliciting comments towards regulatory decisions at this meeting.

Purpose: The U.S. Nuclear Regulatory Commission (NRC) staff will hold a virtual meeting to discuss proposed changes to the 10 CFR 2.206 process described in Management Directive 8.11, "Review Process for 10 CFR 2.206 Petitions" based on recommendations from the report of the U.S. Nuclear Regulatory Commission's Expert Evaluation Team on Concerns Pertaining to Gas Transmission Lines Near the Indian Point Nuclear Power Plant. This is the third public meeting to gather insights from external stakeholders and to provide an understanding of how previous comments have been dispositioned.

This meeting is a follow-up to the August 18, and October 20, 2020, public meetings where the NRC staff presented proposed changes to the 2.206 petition process and answered questions from members of the public.
