This refers to your license amendment request dated April 28, 2021. Please find enclosed Amendment No. 7 increasing your radioactive material authorizations. Please note that several license conditions were updated to the new standard license conditions as detailed in NUREG-1556 Volume 20, Revision 1, "Consolidated Guidance About Materials Licenses: Guidance About Administrative Licensing Procedures."

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license.
