By letter dated October 22, 2020, Dearborn County Hospital, submitted to the U. S. Nuclear Regulatory Commission (NRC) a Request for Consent to direct Change of Control of NRC Materials License No. 13-17327-01 issued to Dearborn County Hospital. Your letter is available electronically from the Agencywide Documents Access and Management System (ADAMS) at Accession No. ML20300A197.

Based on the information provided, we understand that on November 1, 2020, Dearborn County Hospital transferred all assets, including NRC Materials License No. 13-17327-01 to St. Elizabeth Healthcare. We further understand that this transfer did not result in any change to licensed materials, persons using the license material, location of use of licensed material, or persons responsible for the licensee's radiation safety program.

Based on the above understandings and as more fully detailed in the enclosed NRC staff's Safety Evaluation Report which documents the NRC staff's review of the request, the NRC consents to the direct transfer of control.
