Why is the NRC having this meeting?

- Staff is systematically reviewing how Environmental Justice (EJ) is addressed in NRC's programs, policies, and activities.
- This meeting is being conducted to hear various perspectives about NRC programs, policies, and activities, and gather additional input for the EJ Review Team's effort.

What is Environmental Justice?

Environmental justice refers to the federal policy established in 1994 by Executive Order (EO) 12898, which directed federal agencies to identify and address disproportionately high and adverse human health or environmental effects of its programs, policies, and activities on minority and low-income populations.



Commission's April 23, 2021 Staff Requirements Memorandum (ML21113A070)

- A. Evaluate recent Executive Orders and assess whether environmental justice is appropriately considered and addressed given the agency's mission.
- B. Consider the practices of other Federal and State agencies and Tribal governments, and evaluate whether the NRC should incorporate environmental justice beyond implementation through NEPA.
- C. Review the adequacy of the 2004 Commission Policy Statement.
- D. Consider whether establishing formal mechanisms to gather external stakeholder input would benefit any future environmental justice efforts


