

**EVALUATION**

By application dated September 28, 2021 (Agencywide Documents Access and Management System (ADAMS) Package Accession No. ML21271A639), Source Production & Equipment Co., Inc. (the applicant) requested renewal of Certificate of Compliance (CoC) No. 9036, for the Model No. C-1 transportation package. The applicant did not request any changes to the package design or authorized contents. The certificate has been renewed for a 5-year term.

**CONDITIONS**

Condition No. 10 was revised to authorize use of previous revision of the certificate for a period ending October 31, 2021.

Condition No. 11 has been updated to reflect the new expiration date.

The references section has been updated to include this request.

**CONCLUSION**

Based on the statements contained in the application, and the conditions listed above, the staff concludes that the changes indicated do not affect the ability of the package to meet the requirements of 10 CFR Part 71. The CoC has been renewed for a 5-year term that expires on October 31, 2026.
