This letter is in response to the General Electric-Hitachi (GEH) submittal dated March 6, 2020 (Agencywide Documents Access and Management System (ADAMS) Accession No. ML20066J977), supplemental information dated June 2, 2020 (ADAMS Accession No. ML20154K650), and GEH's, November 5, 2020, response (ADAMS Accession No. ML20310A274) to a request for additional information (ADAMS Accession No. ML20209A067) providing the U.S. Nuclear Regulatory Commission (NRC) an updated decommissioning funding plan for the Vallecitos Nuclear Center.

Our review of GEH's submittal has identified additional information that is needed before final action can be taken.
