To Whom It May Concern:

Federal Resources Supply Company ("FRSC") and its subsidiary, KD Analytical Consulting, LLC ("KDA") have been acquired by Noble Supply and Logistics, LLC ("Noble"). This letter is to inform you of the acquisition and of any changes to current operations.

This acquisition took effect on October 27, 2021. Although Noble conducted due diligence during the timeframe leading up to the merger, the specific requirements pertaining to notification and other transfer of control requirements were not clearly identified, and due to the confidential nature of the acquisition, FRSC's RSO was not informed of the merger until after close. FRSC made an erroneous assumption that it did not need to provide formal notice since the license requirements would remain the same after close – i.e., that FRSC would continue operating as the same company with the same personnel and policies/procedures as required by the licenses. After further research, FRSC's RSO determined that notice was necessary and pulled together the necessary documentation to comply with both state and federal requirements.

The attached documentation is intended to satisfy the Transfer of Control notification requirements for the Nuclear Regulatory Commission. If there is anything additional that Noble needs to submit, please let us know as soon as possible.

**Change of Control and/or Change of Ownership  
(Includes Change of Name)**

10 CFR 30.34(b) states that "no license issued or granted pursuant to the regulations...nor any right under a license shall be transferred, assigned or in any manner disposed of, either voluntarily or involuntarily, directly or indirectly, through transfer of control of any license to any person, unless the Commission shall...find that the transfer is in accordance with the provisions of the Act and shall give its consent in writing. Although not specifically addressed by 10 CFR 30.34, licensees undergoing a name change may also be affected by this regulation.

Control over licensed activities can be construed as the authority to decide when and how a license (licensed material and/or activities) will be used. A change of ownership may be an example of a change of control. The central issue is whether the authority over the license has changed. In all cases, determining whether a change of control has taken place or whether a change is in name only is the Commission's responsibility.

Licensees must notify the Commission when they are undergoing a possible change of control and/or a change of name. While this notification is not required within a certain time frame, NRC needs adequate time to review the submittal to ensure that the transfer is in accordance with the regulations.

**Definitions:**

**Control:** Control of a license is in the hands of the person or persons who are empowered to decide when and how that license will be used. That control is to be found in the person or persons who, because of ownership or authority explicitly delegated by the owners, possess the power to determine corporate policy and, thus, the direction of the activities under the license.

**Transferee:** A transferee is an entity that proposes to purchase or otherwise gain control of an NRC-licensed operation.

**Transferor:** A transferor is an NRC licensee selling or otherwise giving up control of a licensed operation.

**Information Needed for Transfer of Control**

Licensees must provide full information and obtain NRC's ***prior written consent*** before transferring control of the license. Provide the following information concerning changes of control by the applicant (transferor and/or transferee, as appropriate). **If any items are not applicable, so state.**

1. Describe any planned changes in the organization, including but not limited to, transfer of stocks or assets and mergers, change in members on Board of Directors, etc. Provide the new licensee name, mailing address, and contact information, including phone numbers. **Clearly identify when the amendment request is due to a name change only. ANSWER: Noble Supply Company acquired Federal Resources Supply Company. Federal Resources Supply Company will continue to operate as normal with the only difference being that it is now owned by Noble. See attached "Noble ITAR Notification Letter" for more details.**
2. Describe any changes in personnel or duties that relate to the licensed program. Include training and experience for new personnel and any changes in the training program. **ANSWER: There are no changes in personnel, policies, procedures due to the acquisition.**
3. Describe any changes in the location, facilities, equipment, radiation safety program, use, possession, waste management, or other procedures that relate to the licensed program. **ANSWER: There are no changes in location, facilities, equipment, the radiation safety program, use, possession, waste management, or other procedures that relate to the licensed program.**

4. Describe the status of the licensee's facilities, equipment, and radiation safety program, including any known contamination and whether decontamination will occur prior to transfer. Include the status of calibrations, leak tests, area surveys, wipe tests, training, quality control, and related records. **ANSWER: All inspections, audits, inventories, wipe test, calibrations, etc. are up to date and have not been affected by the acquisition.**
5. If current decommissioning funding plans (DFP) will be changed as a result of the transfer, the revised DFP should be submitted. If other financial assurance documents will be changed as a result of the transfer, confirm that all financial assurance instruments associated with the license will be held in the transferee's name before the license is transferred, and as required by 10 CFR 30.35(f), the licensee must, within 30 days, submit financial instruments reflecting such changes. **ANSWER: No changes.**
6. Confirm that all records concerning the safe and effective decommissioning of the facility will be transferred to the transferee or to NRC, as appropriate. These records include documentation of surveys of ambient radiation levels and fixed and/or removable contamination, including methods and sensitivity. **ANSWER: No changes. Federal Resources will continue to operate as the principal License holder.**
7. Confirm that both transferor and transferee agree to transferring control of the licensed material and activity, and the conditions of transfer, and that the transferee has been made aware of any open inspection items and its responsibility for possible resulting enforcement actions. **ANSWER: There are no open inspection items. Federal Resources will remain the principal license holder but now be owned by Noble Supply Company.**
8. Confirm that the transferee will abide by all constraints, conditions, requirements, representations, and commitments of the transferor or that the transferee will submit a complete description of the proposed licensed program. **ANSWER: See attached letter from Noble Supply Company confirming to abide by all constraints, conditions, requirements, representations, and commitments of the transferor.**
9. The transferee, in the case of fuel cycle facilities, shall provide documentation showing that it is financially qualified to conduct normal operations. The information can be in the form of income statements and balance sheet forecasts. **ANSWER: Not a fuel cycle facility.**
