SUBJECT: RESPONSE TO NRC INSPECTION REPORT 030-38579/2021-001, NOTICE OF VIOLATION

Dear Mr. McCain:

On December 29, 2021, the U.S. Nuclear Regulatory Commission (NRC) cited American Piping Inspection, for two violations of NRC regulations. The NRC Inspection Report 030-38579/2021-001, dated December 29, 2021 with enclosed Notice of Violation (Notice) required you to respond in writing to the NRC within 30 days. In a letter dated January 5, 2022, you provided your response to the Notice of Violation.

After reviewing the information provided in your response to the Notice, we have concluded that your proposed actions appear to adequately address the regulatory non-compliances described in the Notice for Violations. We will review your implementation of these corrective actions during a future inspection to determine whether full compliance has been restored and whether compliance will be maintained.
