Enclosed is Amendment No. 6 to Allstate Consultants, LLC (your) U.S. Nuclear Regulatory Commission (NRC) Materials License No. 24-32454-01 in accordance with your December 27, 2021 letter, requesting to add a new location of use to the license. Please note that we have added the location, but the prior location of use, listed in Condition No. 10B., cannot be removed at this time. To remove the prior location of use, please provide a signed and dated letter containing your request. Attach final disposition information with your request, including the most recent leak tests for the gauges and confirmation that the gauges have been received by another authorized licensee, the gauge manufacturer, or a location of use listed on your license. Your letter is available electronically from the Agencywide Documents Access and Management System (ADAMS) at Accession No. ML21361A305. The NRC's ADAMS is accessible from the NRC's Web site at <https://www.nrc.gov/reading-rm/adams.html>.

Please review the enclosed document carefully, and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. NRC Region III office at 630-829-9892 so that we may provide appropriate corrections and answers.

An environmental assessment for this action is not required because this action is categorically excluded under Title 10 of the *Code of Federal Regulations* (10 CFR) Section 51.22(c).

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation; or imposition of a civil penalty; or an Order suspending, modifying, or revoking your license as specified in the NRC Enforcement Policy. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance that NRC expects of its licensees.
