Enclosed is Amendment No. 22 to DTE Energy's (your) U.S. Nuclear Regulatory Commission (NRC) Materials License No. 21-02335-06 in accordance with your January 27, 2022 request to extend the license term for your license. As we discussed, although a 15 term is now allowed, your license term was extended by 2 years following the planned conclusion of conducting principal activities under the license. Your letter is available electronically from the Agencywide Documents Access and Management System (ADAMS) at Accession No. ML22031A019. Please review the enclosed document carefully, and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. NRC Region III office at 630-829-9892 so that we may provide appropriate corrections and answers. Please note that additional information may be needed in support of your decommissioning financial assurance submission, which is being reviewed under a separate action. Our office will contact you when additional information is needed, in support of that review.

An environmental assessment for this action is not required because this action is categorically excluded under Title 10 of the *Code of Federal Regulations* (10 CFR) Section 51.22(c).

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation; or imposition of a civil penalty; or an Order suspending, modifying, or revoking your license as specified in the NRC Enforcement Policy. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance that NRC expects of its licensees.
