SUBJECT: RESPONSE TO NRC INSPECTION REPORT 030-09603/2021-001 AND NOTICE OF VIOLATION

Dear Ms. Rycraft:

On February 9, 2022, the U.S. Nuclear Regulatory Commission (NRC) cited Huron Regional Medical Center for three Severity Level IV violations of NRC requirements. The violations concerned the following: (1) a written directive for a therapeutic administration of samarium-153 was not signed by an authorized user; (2) a written directive for another therapeutic administration of samarium-153 did not include the prescribed dosage; and (3) the instrument used to measure the activity of unsealed byproduct material for administration to patients was not calibrated in accordance with nationally recognized standards. NRC Inspection Report 030-09603/2021-001 with enclosed Notice of Violation (Notice) required you to reply in writing in 30 days (NRC Agencywide Documents Access and Management System (ADAMS) Accession No. [ML22038A597](#)). In a letter dated February 17, 2022, you provided your reply to the Notice (ADAMS Accession No. [ML22055A469](#)).

After reviewing the information provided in your reply to the Notice, we have concluded that your completed and proposed corrective actions appear to adequately address the regulatory non-compliance described in the Notice. We will review your implementation of these corrective actions during a future inspection to determine whether full compliance has been restored and whether compliance will be maintained.

In accordance with 10 CFR 2.390 of the NRC's "Agency Rules of Practice and Procedures," a copy of this letter will be made available electronically for public inspection in the NRC Public Document Room or from the NRC's ADAMS, accessible from the NRC Web site at <http://www.nrc.gov/reading-rm/adams.html>.
