

Background




- One General Electric BWR
- 2004 Mwt
- Net Capacity: 640 Mwe
- Capital improvements include uprate & efficiencies since initial LR
- No refurbishment anticipated for subsequent period of extended operation (SPEO)

Plant Aerial


- MNGP is owned by Xcel Energy, the licensee and applicant, and operated by Northern States Power Company.
- The MNGP plant site is located within the city limits Monticello, Minnesota, on the southern bank of Mississippi River.
- The property (approx. 2000 acres) straddles the river and is located in Wright and Sherburne Counties, MN.
- The MNGP EAB falls within the site boundary.




Region (50-mile) Map

Critical Habitat

No designated critical habitat is listed for Sherburne or Wright counties.

Essential Fish Habitat

 No essential fish habitat (EFH) is located within the vicinity of MNGP, nor were any EFH areas protected from fishing.

Habitat Areas of Particular Concern

No habitat areas of particular concern (HAPC) located within the six-mile vicinity of MNGP.

Threatened and Endangered Species

- Three Federally listed threatened, endangered or candidate species are listed within Sherburne and Wright Counties.
- Twenty-two state listed species are located within Sherburne and Wright counties.

Cultural Resources

The MOSAP and SHPO databases list no cultural resources within the MNGP site.

- Incorporate lessons learned from previously submitted ER & SAMA analyses into the MNGP ER and basis documents
 - SAMA Evaluations
 - Agency Consultations
 - Alternatives
- Review and incorporate applicable information into MNGP ER based on previously submitted SLR ER RAIs (e.g., PSL, PBN, PTN, SPS, ONS, PBAPS)
- Allocate sufficient time to test IT resources (e.g., access to e-Portal and Microsoft Teams) and offer to walk through the organization presented on the e-Portal prior to environmental audit.
