In order to continue prompt review of your application, we request that you submit your response to this letter within 30 calendar days from the date of this letter.

Please be aware that you may request that certain portions of your submittal to NRC be withheld from public disclosure as proprietary information. While it is allowable, please refrain from submitting proprietary information in support of a license unless necessary. Keep in mind that all NRC licenses are considered to be in the public domain, and therefore may be viewed by any member of the public who requests to see them.
