**Re: Updated Amendment to License No. 21-01430-01**

Dear Madam or Sir:

Please edit our amendment dated March 14<sup>th</sup>, 2022 as follows:

1. For the address listed on our license for subitem **10 C** (406 E Elm Street, Carson City, Michigan, 48811) add the room (127FL01053 "office" on attached diagram) as an area of use for 35.200 limited injections for stress testing **using Tc-99**. Note that the physician office making this request has a separate address of 245 S. 2nd Street Carson City, Michigan 48811, but is physically in the same building as the previously listed hospital address already on our license. The isotope will be under constant surveillance as it is transferred from the nuclear medicine hot lab and administered in the proposed stress room. Please see the attached floor diagram for additional details.
