This refers to your license amendment request dated March 10, 2022. Please find enclosed Amendment No. 11 removing the authorization for 10 CRR 35.300 materials, removing two physicians and adding Dr. Shah as an authorized user under your license.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
