Enclosed is Amendment No. 68 to Baptist Healthcare System d/b/a Baptist Health Floyd's (your) U.S. Nuclear Regulatory Commission (NRC) Materials License No. 13-12371-01 in accordance with your May 3, 2022 request to remove the Scottsburg, Indiana location of use from your license. Your letter is available electronically from the Agencywide Documents Access and Management System (ADAMS) at Accession No. ML22124A168. Please review the enclosed document carefully, and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. NRC Region III office at 630-829-9892 so that we may provide appropriate corrections and answers.

An environmental assessment for this action is not required because this action is categorically excluded under 10 CFR Section 51.22(c).

The NRC staff has reviewed your final status surveys for the 705 W Fairground Rd., Scottsburg, Indiana location of use. Based on its review, the NRC staff has concluded that all licensable radioactive material has been removed from the facility and residual radioactive material attributable to licensed activities does not exceed current NRC criteria. Based on these conclusions, no further remediation or actions are required with respect to NRC-regulated material at the 705 W Fairground Rd. location of use. Your facilities at 705 W Fairground Rd., Scottsburg, Indiana, are suitable for unrestricted use.

You will be periodically inspected by NRC.
