On April 27, 2022, the U.S. Nuclear Regulatory Commission (NRC) staff held a virtual Microsoft Teams meeting with Niowave, Inc. (Niowave). Niowave had requested this Observation Meeting to discuss its proposed 10 CFR Part 70 application for a medical isotope facility it plans to construct in Lansing, Michigan.
