DESCRIPTION OF MATERIAL(S) OR FACILITY(IES)

The license authorizes the export of up to 1,379,102 kilograms of low-level waste, generated from medical isotope and radio-pharmaceuticals production. The treated material, to be returned to Canada, will consist of post-processed solid radioactive waste after thermal processing, stabilization, and solidification. The total activity level of all radioactive contaminants combined shall not exceed 3.99 TBq over the duration of the license.

Neither this license nor any right under this license shall be assigned or otherwise transferred in violation of the provisions of the Atomic Energy Act of 1954, as amended, and the Energy Reorganization Act of 1974.

This license is subject to the right of recapture or control by Section 108 of the Atomic Energy Act of 1954, as amended, and to all the other provisions of said Acts, now or hereafter in effect and to all valid rules and regulations of the NRC.
