This refers to your license amendment request dated April 11, 2022. Please find enclosed Amendment No. 25 authorizing the expansion of the existing PET imaging room at your Newark, Delaware location to accommodate the new GE Discovery DSTE PET/CT unit.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
