The U.S. Nuclear Regulatory Commission (NRC) staff has received your submittal dated July 26, 2022 (Agencywide Documents Access and Management System (ADAMS) Number ML22209A132), transmitting the Louisiana Energy Services, LLC doing business as URENCO, USA, LLC (UUSA) Compliance Plan. The submittal provides UUSA's plan to come into compliance with Title 32 of the *Code of Federal Regulations* Part 117, "National Industrial Security Program Operating Manual (NISPOM)," consistent with the NRC's letter issued June 1, 2022 (ML22144A408, non-public).

The NRC staff has completed the acceptance review of your submittal and has identified no administrative omissions or deficiencies that would prevent us from proceeding with a detailed review. Your submittal will be reviewed using the Enterprise Project Identification Number (EPID) L-2022-SPR-0008. Please reference this number and Docket Number 07003103 in any future correspondence associated with this request.

Based on our preliminary evaluation and projection of current review schedules, we anticipate completing our formal review by November 2022. This schedule includes the issuance, if needed, of a request for additional information (RAI). Please note that these dates could change depending on the findings of our technical review, urgent assignments, or other factors, such as whether your responses to the RAI are or not adequate.

The NRC staff estimates that completing the review of your submittal will require approximately 40 staff hours which corresponds to about \$11,520.00 (\$288/hr.) We will promptly communicate any significant change in the schedule.

In accordance with Title 10 of the *Code of Federal Regulations*, Section 2.390 of the NRC's "Agency Rules of Practice and Procedure," a copy of this letter will be available electronically for public inspection in the NRC Public Document Room or from the Publicly Available Records component of the NRC's ADAMS.
