C&H Engineering and Surveying, Inc. is in the process of merging with IMEG Corp. We would like to Amend our NRC License (25-35009-01) to allow for a licensee name change to IMEG Corp, and Licensee address change to 623 26th Ave., Rock Island, IL, 61201. The license material will still be used and stored at our current facility located at 1091 Stoneridge Drive, Bozeman MT 59718. Our day-to-day operations will stay the same, as will the intended use of the licensed material to aid in engineering design and inspection.

- 2. Describe any changes in personnel or duties that relate to the licensed program. Include training and experience for new personnel and any changes in the training program.**

The Amendment request is only for the Licensee Name Change and Address Change. The licensed material will still be used and stored at our current facility located at 1091 Stoneridge Drive, Bozeman, MT 59718 as listed on the current NRC License Number: (25-35009-01). Michael J. Welch will maintain his position as our onsite facility RSO as listed on the current license.

Our current training program will remain the same, where all authorized users are required to take and pass a Nuclear Gauge Safety Course including USDOT Hazmat meeting the requirements of 49 CFR 172 subpart H. Copies of training certificates will be and will continue to be kept on file for each authorized user.

3. **Describe any changes in the location, facilities, equipment, radiation safety program, use, possession, waste management, or other procedures that relate to the licensed program.**

There will be no changes for the use and storage of the licensed material and equipment. the licensed material will be used and stored at our current facility located at 1091 Stoneridge Drive, Bozeman, MT 59718 as listed on the current NRC License (25-35009-01).

4. **Describe the status of the licensee's facilities, equipment, and radiation safety program, including any known contamination and whether decontamination will occur prior to transfer. Include the status of calibrations, leak tests, area surveys, wipe tests, training, quality control, and related records.**

Our current facility is currently and will continue to operate as an engineer consulting firm. We currently own 3 Seaman C-300 nuclear density gauges and 1 Seaman C-200 nuclear density gauge. All gauges are stored in a manner that is consistent with the two physical barrier rule and in a manner to keep the public dose below 100 mrem per year.

The licensed material will be used and stored at our current facility as it has been in the past and as listed on the current NRC license and will continue in this manner.

We current operate with our radiation safety plan that is associated with the NRC License 25-35009-01. There will be no changes in the current radiation safety plan other than the licensee name and will continue to operate under this safety plan.

At this time there are no known contaminations, the licensed material will be used and stored at our current facility as listed on the NRC License and will not be physically transferred. This amendment request is only to allow the licensee name and address change.

Our current gauges are calibrated as needed, with the most recent calibration performed by Seaman Nuclear in August of 2021.

All gauges are physically inventoried at 6-month intervals or earlier. A record of each gauge inventory including which gauge, serial number of the gauge, person conducting the inventory, and the date of the inventory is kept on file at our storage facility.

All gauges are leak tested at 6-month intervals or earlier. The leak tests are conducted by Qal-Tek Associates and meet the NRC Requirements. All leak tests are kept on file at our storage facility. None of the gauges have been found to be leaking. The most recent leaks tests were done on June 28, 2022 and no leaks were found.

5. **If current decommissioning funding plans (DFP) will be changed as a result of the transfer, the revised DFP should be submitted. If other financial assurance documents will be changed as a result of the transfer, confirm that all financial assurance instruments associated with the license will be held in the transferee's name before the license is transferred, and as required by 10 CFR 30.35(f), the licensee must, within 30 days, submit financial instruments reflecting such changes.**

Decommissioning funding plans are not affiliated with NRC License # 25-35009-01.

6. **Confirm that all records concerning the safe and effective decommissioning of the facility will be transferred to the transferee or to NRC, as appropriate. These records include documentation of surveys of ambient radiation levels and fixed and/or removable contamination, including methods and sensitivity.**

The licensed material will be used and stored at our current facility as they have been in the past and as stated on the current NRC License. This amendment request is to allow the licensee name and address change only.

7. **Confirm that both transferor and transferee agree to transferring control of the licensed material and activity, and the conditions of transfer, and that the transferee has been made aware of any open inspection items and its responsibility for possible resulting enforcement actions.**

IMEG Corp has been provided copies of all documents associated with NRC License number : 25-35009-01. There are no know open inspections associated with the NRC License at this time. IMEG Corp is aware of everything covered within the current NRC License and the responsibilities associated with it.

8. **Confirm that the transferee will abide by all constraints, conditions, requirements, representations, and commitments of the transferor or that the transferee will submit a complete description of the proposed licensed program.**

IMEG Corp has been provided copies of all documents associated with NRC License Number 25-35009-01 and will abide by all constraints, conditions, requirements, representations, and commitments of the transferor and/or that the IMEG Corp will submit a complete description of the proposed licensed program.

9. **The transferee, in the case of fuel cycle facilities, shall provide documentation showing that it is financially qualified to conduct normal operations. The information can be in the form of income statements and balance sheet forecasts.**

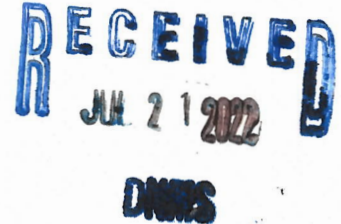

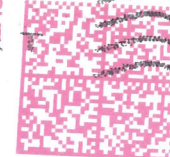

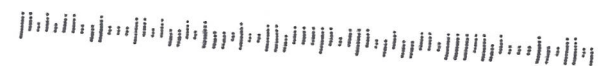
