HOYLE: The Commissioners have agreed to place immediately before the public meeting a reasonable number of copies of the SECY paper or papers identified on the Commission's schedule as the central issue for discussion, to place these on a table in the rear of the Commission meeting room so that the public can more easily follow the discussion. The paper will be placed in the Public Document Room after the meeting.

The Commissioners have also agreed not to make public allied papers at this time. However, this is a matter
