Good afternoon, Mr. Schumacher:

Our office has reviewed the licensee representative's – Rosalind Norris's – July 8, 2022 letter requesting the name change from Brooks Life Sciences, Inc. and two added locations of use (as storage only as a commercial service) for the referenced license.

To complete our review, could you please provide a signed and dated letter with information for each of the new Camby Rd. location and the added suite at Fortune Circle West and Camby Rd. location to be added to the license:

- A facility diagram;
- The receiving, storage and shipping areas, clearly indicated in the response;
- The scale or dimensions of the added facilities including of the specific receiving, shipping, and commercial storage areas, shown on the diagram;
- An indication of the locations of any locked doors, storage cabinets, or refrigerators for licensed radioactive materials, shown on the diagram.

you could provide the information within the next 14 days (on or before July 28, 2022), it is appreciated. You may submit your information electronically as a signed and dated letter

attached in pdf format, to an email message.
