SUBJECT: RESPONSE TO NRC INSPECTION REPORT 030-06803/2022-001 AND NOTICE OF VIOLATION

Dear Jeremiah Rawson:

On June 27, 2022, the U.S. Nuclear Regulatory Commission (NRC) cited Sisecam Wyoming, LLC (formerly Ciner Wyoming, LLC) for two Severity Level IV violations of NRC requirements. The violations involved the failures to: (1) review the radiation protection program in accordance with Title 10 of the *Code of Federal Regulations* (10 CFR) Part 20; and (2) perform and/or keep records of leak tests of certain sealed sources. NRC Inspection Report 030-06803/2022-001 with enclosed Notice of Violation (Notice) required you to reply in writing in 30 days (NRC Agencywide Documents Access and Management System (ADAMS) Accession No. [ML22178A184](#)). In a letter dated June 28, 2022, you provided your reply to the Notice (ADAMS Accession No. [ML22206A267](#)).

After reviewing the information provided in your reply to the Notice, we have concluded that your completed and proposed corrective actions appear to adequately address the regulatory non-compliance described in the Notice. We will review your implementation of these corrective actions during a future inspection to determine whether full compliance has been restored and whether compliance will be maintained.

In accordance with 10 CFR 2.390 of the NRC's "Agency Rules of Practice and Procedures," a copy of this letter will be made available electronically for public inspection in the NRC Public Document Room or from the NRC's ADAMS, accessible from the NRC Web site at <http://www.nrc.gov/reading-rm/adams.html>.
