The U.S. Nuclear Regulatory Commission (NRC) staff has reviewed your letter dated July 26, 2022 (Agencywide Documents Access and Management System (ADAMS) Accession No. ML22209A132). The letter contains the Louisiana Energy Services, LLC., doing business as URENCO, USA (UUSA) Compliance Plan for implementation of requirements in Title 32 of the *Code of Federal Regulation* (32 CFR) Part 117, "National Industrial Security Program Operating Manual." UUSA's Compliance Plan was submitted in response to NRC's letter issued June 1, 2022, (ML22144A408, non-public).

The NRC staff's review of the UUSA Compliance Plan identified that additional information is needed before a final decision can be made on its approval. The additional information, outlined in the enclosure, should be provided to the NRC within 30 days from the date of this letter.

Pending your response to our request for additional information, we anticipate completing our review of UUSA's Compliance Plan by the end of October 2022. This date could change depending on the findings of our technical review, urgent assignments, or other factors. We will promptly communicate any significant changes to this schedule.
