Good morning. Thank you for the updated documents. I accessed them successfully, per your instructions.

I noted one typo – Section 6, Item O – should indicate Yb-177 rather than Yb-175.

Upon review, it seems this typo occurred after issuance of Amendment 4 (which initially correctly included Yb-177), but subsequently changed to Yb-175 upon slight revision to Item K. I've attached those documents for reference.

Apologies for not catching the discrepancy sooner. Please let me know if you require anything further to correct the listed isotope. Thank you.
