This letter concerns the subject request to amend your U.S. Nuclear Regulatory Commission (NRC) License No. 52-25066-01. You have requested to terminate the license. Your amendment request is available electronically from the Agencywide Documents Access and Management System (ADAMS) at Accession No. ML22151A063.

Based on the telephone conversation on June 16, 2022, and the electronic mail on July 14, 2022, you informed us that you still possess one device (in a CNA tube) and cannot terminate the license at this time. Therefore, we have administratively closed your license amendment request. Note that if you submit a new request at a later date, you may refer to Control No. 631403 for the documentation you have already submitted. This documentation includes confirmation of the transfer of the other devices previously possessed under the license. We further understand that you have applied for Small Entity status; please remember to apply for this each year that the license is still active.
