SUBJECT: NRC INSPECTION REPORT 030-10346/2022-001 AND NOTICE OF VIOLATION

Dear Mr. Donald Millar:

This letter refers to the routine, unannounced inspection conducted on June 7, 2022 at your Anchorage, Alaska facility. This inspection examined activities conducted under your license as they relate to public health and safety, and to confirm compliance with the U.S. Nuclear Regulatory Commission's (NRC) rules and regulations and with the conditions of your license. Within these areas, the inspection consisted of a selected examination of procedures and representative records, observations of activities, and interviews with personnel. A final exit meeting was held telephonically with your Radiation Safety Officer, Riley Peck, on August 8, 2022, discussing the results of the inspection.

Based on the results of this inspection, the NRC has determined that a Severity Level IV violation of NRC requirements occurred. The violation was evaluated in accordance with the NRC Enforcement Policy which can be found on the NRC's Web site at <https://www.nrc.gov/about-nrc/regulatory/enforcement/enforce-pol.html>. The violation involved a failure to meet requirements in 10 CFR Part 37 and is characterized in the non-public enclosure to this letter. The violation is being cited in the enclosed Notice of Violation (Notice) because it was identified by the NRC during the inspection.

You are required to respond to this letter and should follow the instructions specified in the enclosed Notice when preparing your response. The guidance in NRC Information Notice 96-28, "Suggested Guidance Relating to Development and Implementation of Corrective Action," may be helpful in preparing your response. You can find the Information Notice on the NRC website at: <https://www.nrc.gov/reading-rm/doc-collections/gen-comm/info-notices/1996/in96028.html>. Information regarding the reason for the violation, the corrective actions taken and planned to correct the violation and prevent recurrence, and the date when full compliance will be (was) achieved should be addressed. The NRC review of your response to the Notice will also determine whether further enforcement action is necessary to ensure compliance with regulatory requirements.

The enclosure contains Sensitive Unclassified Non-Safeguards Information (SUNSI). When separated from the enclosure, this letter is decontrolled.
